Please allow this letter to serve as a response to your fax dated November 25, 2009. Our responses are in the order in which you requested additional information in the fax.

We confirm that only authorized personnel will have access to radioactive materials located in the locking cabinets.

The cabinets located at our 8075 North Shadeland and 1402 East County Line Road addresses are controlled by a keypad lock. The cabinet located at 1400 North Ritter is controlled by a lock and key.

The cabinets located at 8075 North Shadeland and 1402 East County Line Road are actually closets and are therefore not removable from the structure itself. The cabinet located at 1400 North Ritter is bolted to the floor.
