Finally got the fax on the disposal of the miscellaneous sources for Medical Imaging Center. It is attached.

In addition to the Cardinal Health notes:

- a) the Co-57 vial reference source, SN 1333-83-22, of 5.521 mCi on 01/01/09 was given to Cottage Grove Cardiology, Bloomfield, CT. NRC Lic #06-30260-01
- b) the Ba-133 vial reference source, SN 3581083A-01, of 0.288 mCi on 10/27/83 was given to Jefferson Radiology, Hartford, CT. NRC License #06-28502-01

Those last 2 sources were given away between Oct 19 - 26; which represents 2660 uCi of Co-57, and, 52.8 uCi of Ba-133.
