STATUS REPORT - CONSOLIDATED EDISON COMPANY - INDIAN POINT UNIT 3

Status and Problems

An IP-3 environmental review schedule has been perposed in cooperation with ORNL. A copy of the schedule for the Blue Book is enclosed. The proposed dates for issuance of the DES and FES are May 9, and September 7, 1973, respectively. Several potential publiches exist in meeting this schedule and are discussed in the attachment. The major problem concerns the date of submission of Con Ed's SER 3 and SER 4 which will be February 9, and March 9, 1973, respectively. D. Remshaw, Licensing Administrator for Con Ed, told me on January 2, that these supplements, which are on biological effects of plant operation, will contain new information. This information is based on the 1972 ecological studies and also some 1973 data which are being collected.

The preparation of the DES should include the impacts of all 3 units. Possibly the impacts of fossil fuel plants (Bowline and Roseton) may have to be considered. To expedite the preparation, as much of the IP-2 FES could be used and cross referenced. The FES will be prepared under a "green cover exercise." R. Rush is the ORNL team leader.

Schedule

The official date for ORNL to start its review is January 3, 1973. Depending on completion of IP-2 hearings scheduled for January 19, 1973, the next major milestone is for me to travel to ORNL on January 22, 1973, to scope out the work on the DES. Con Ed has sent a letter dated December 27, 1972, in response to our letter of November 16, 1972, which discusses the dates of submission of the SERs.
