Pursuant to 10 CFR 73.5, Virginia Electric and Power Company (Dominion) is requesting exemptions from portions of 10 CFR 73.55 of the final rule, Power Reactor Security Requirements, which was published March 27, 2009 in the Federal Register. Specifically, Dominion is requesting that the compliance date for implementing certain measures required by the new rule be extended for Surry Power Station. The exemption requests are provided in Attachment 1 and list of milestone dates for the exemptions are provided as Attachment 2.
