Subject: Systematic Assessment of Licensee Performance (SALP): Final  
Report No. 50-286/88-99

This refers to the evaluation of the Indian Point 3 Nuclear Power Plant operated by the New York Power Authority, conducted by the NRC staff on January 16, 1990. This report was forwarded to you on March 7, 1990, and was discussed with you in a meeting on April 4, 1990.

The list of attendees at that meeting is attached as Enclosure 1. The NRC Final SALP Report is forwarded as Enclosure 2. Our letter of March 7, 1990, that forwarded the initial SALP Report, and your letter of May 10, 1990, that provided comments relative to that report and the April 4, 1990 meeting, are provided as Enclosures 3 and 4, respectively.

The comments provided during the April 4, 1990 meeting and in your written response of May 10, 1990, have been considered and some revisions have been made to the SALP Report to correct inaccuracies. The rationale for these changes is enclosed in the revision sheet, appended as Enclosure 5.

We have reviewed in detail the information provided in Attachment II to your May 10, 1990 response regarding the Security section of the SALP Report. The SALP Board was reconvened on June 5, 1990, and after careful review, determined that a SALP rating of Category 3 for the Security functional area was still appropriate. Although some changes were made as a result of our review of your response as explained in Enclosure 5, your response indicated to the SALP Board that real progress in this area could not be assured until additional management level discussions between NRC and NYPA took place. As a result, the SALP Board made an additional recommendation to hold such a meeting. I concur with that recommendation and believe it is important that we meet soon to establish a dialogue directed toward producing a clear understanding of our expectations and an effective working relationship in this important functional area.
