On December 11, 1982, the Commission issued Amendment No. 31 to Facility Operating License No. DPR-5 for the Indian Point Station Unit No. 1 and Amendment No. 82 to Facility Operating License No. DPR-26 for the Indian Point Nuclear Generating Unit No. 2, which included Revised Technical Specifications.
