

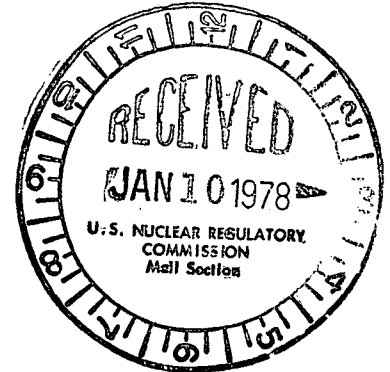

Consolidated Edison Company of New York, Inc. transmits herewith three (3) signed originals and forty (40) copies of each of the documents described below.

1. "Application for Amendment to Operating License," sworn to on December 16, 1977. This application requests an amendment to Sections 1.0, 4.5 and 4.6 in the Technical Specifications to clarify surveillance testing intervals and requirements and effect editorial changes. Consolidated Edison also requests a further change to Section 4.5 which, in addition to those changes to Section 4.2 and 4.3 proposed in Mr. Cahill's May 2, 1977 and November 2, 1977 Applications, is deemed necessary to conform the Technical Specifications with the revised requirements of 10 CFR Part 50.55(a). The changes to Section 4.5 requested in this Application supersede those proposed changes to Section 4.5 contained in the November 2, 1977 Application.

2. "Amendment No. 1 to Application for Amendment to Operating License," sworn to on December 16, 1977. This application amends Con Edison's March 23, 1977 Application to effect further typographical, editorial and technical changes to Table 3.12-1 and Section 4.12 of the Technical Specifications. The proposed changes as described in the Safety Evaluation of

Attachment B to the March 23, 1977 Application are still requested but the proposed technical specification page revisions contained in Attachment A of that Application are superseded by those contained in Attachment A of this Amendment.

3. "Amendment No. 1 to Application for Amendment to Operating License," sworn to on December 16, 1977. This application amends Con Edison's April 16, 1976 Application to effect several typographical and editorial changes to the specific Technical Specification revisions proposed therein and to now request that section 3.3 of the Technical Specifications also be amended to incorporate additional limiting conditions for operation for certain systems utilized in the containment leakage testing program. In addition, Consolidated Edison requests that the proposed sections 3.6 and 4.4 be modified to reflect addition of hardware as part of the Overpressure Protection System modification and to establish the surveillance interval for testing of containment isolation valves.


