RE: Fifteenth Update to Disclosures Pursuant to 10 CFR § 2.336; *Tennessee Valley Authority* (Bellefonte Nuclear Power Plant, Units 3 and 4), Docket Nos. 52-014-COL and 52-015-COL

Pursuant to 10 CFR § 2.336 and the agreement among the parties, as approved by the Atomic Safety and Licensing Board's (Board) Order dated October 14, 2008, the Tennessee Valley Authority (TVA) is providing the fifteenth update to its disclosures with respect to Intervenor's remaining Contentions NEPA-B and NEPA-N, as restated and admitted by the Board on September 12, 2008 (LBP-08-16).

In order to compile the indices in Enclosures 2, 3, and 4, a search was conducted of documents in TVA's possession, custody, or control since the fourteenth update to the disclosures dated November 20, 2009. Attached is a supporting affidavit. TVA's fifteenth update to the disclosures consists of the following:

- Enclosure 1 is reserved for the names, addresses, and telephone numbers of the persons upon whose opinion TVA will base its positions on the contentions and upon whom TVA may rely as a witness, and a copy of the analyses and authorities upon which they base their opinions.

TVA has not yet identified witnesses for any hearing on the contentions, and will update Enclosure 1 when it has identified its witnesses.

- Enclosure 2 provides a description, by category and location, of all relevant non-privileged documents, data compilations, and tangible things in the possession, custody, or control of TVA that are relevant to the admitted contentions in this proceeding. If you determine that you would like a copy of any of these documents, please inform me of which documents you would like, and I will provide a copy to you.
- Enclosure 3 provides an index of documents, data compilations, or tangible things that may be relevant to the contentions but that contain proprietary information, Sensitive Unclassified Non-Safeguards Information (SUNSI), or otherwise protected information. Upon request by the NRC staff, TVA will provide a copy using the procedure in 10 CFR § 2.390. If the Intervenors desire a copy, TVA will work with the Intervenors to develop a mutually acceptable draft Protective Order for issuance by the Board and a Non-Disclosure Agreement for signature by those persons working with the Intervenors who desire a copy. TVA will provide any requested proprietary documents to the Intervenors after the Board has entered a Protective Order and the Intervenors have signed and returned to TVA the Non-Disclosure Agreement.
- Enclosure 4 provides an index of relevant documents that are otherwise publicly available.

In the event that TVA identifies additional relevant documents or the witnesses for any hearing on the contentions, TVA will update these disclosures within 30 days, as required by 10 CFR § 2.336(d) and the Board's Order dated October 14, 2008 regarding the joint agreement among the parties on mandatory disclosures.

In order to compile these enclosures, TVA made a reasonable search of its records since it filed its fourteenth update to the disclosures. We are attaching an affidavit which attests that all relevant materials identified by this search have been disclosed, and that the disclosures are accurate and complete as of December 7, 2009. Also, we have highlighted the additions to the logs since the last disclosures.

TVA has been conservative in identifying documents for inclusion in Enclosures 2, 3, and 4. By identifying documents on those Enclosures, TVA does not necessarily concede that the documents are in fact relevant or material to the admitted contentions.

AFFIDAVIT

1. My name is Andrea Sterdis. My title is Manager, Nuclear Licensing and Industry Affairs, at the Tennessee Valley Authority (TVA). Working with the attorneys for TVA, I have been responsible for managing the searches, collection, and compilation of documents, data compilations, and tangible things to comply with the mandatory disclosure requirements in 10 CFR § 2.336.
2. This Affidavit relates to the fifteenth update to the disclosures that TVA is providing on December 21, 2009, in the above-captioned proceeding pursuant to 10 CFR § 2.336 and the Board Order regarding the parties' joint agreement on mandatory disclosures, dated October 14, 2008.
3. A search was conducted of documents, data compilations, and tangible things under the custody and control of TVA since it filed its fourteenth update to the disclosures for the types of information specified in 10 CFR § 2.336(a). As provided in 10 CFR § 2.336(c), this search was conducted based on information and documents reasonably available to TVA:
 - a. The searches encompassed both electronic and paper documents.

- b. The searches encompassed both Bellefonte 3 & 4 project-related files and documents in the possession and control of individuals who have worked on the Bellefonte 3 & 4 project.
 - c. The searches were conducted not only of documents, data compilations, and tangible things in the possession and control of TVA, but also documents, data compilations, and tangible things in the possession and control of NuStart Energy Development, LLC (NuStart), who was responsible for preparing the Bellefonte combined license application.
 - d. Searches were conducted by members of NuStart and contractors of TVA and NuStart, to the extent that they and their employees worked on the Bellefonte 3 & 4 project and to the extent they possessed documents, data compilations, and tangible things used on the Bellefonte 3 & 4 project.
 - e. Searches did not encompass documents in the possession of individuals who did not work on the Bellefonte 3 & 4 project or files unrelated to the Bellefonte 3 & 4 project.
- 4. Enclosure 2 provides the index of relevant non-privileged, non-protected documents, data compilations, and tangible things that were located as a result of this search.
 - 5. Enclosure 3 provides the index of relevant documents, data compilations, and tangible things containing proprietary-related information.
 - 6. Enclosure 4 provides the index of relevant documents, data compilations, and tangible things that are publicly available.
