The purpose of this modification is to (1) exercise option year 2 of the contract extending the contract period of performance, (2) increase the estimated ceiling amount by \$603,688.00, from \$1,144,864.00 to \$1,748,552.00, and the obligated amount by \$600,000.00 from \$1,144,864.00 to \$1,744,864.00; and (3) change the NRC Project Officer listing. Accordingly, the contract is modified as follows:

1. "Exercise option year 2 and extend the period of performance from February 1, 2010 through January 31, 2011.
2. Section B.3, Consideration and Obligation-Delivery Orders (JUN 1988)  
(a) and (b) is deleted in its entirety and the following paragraph is substituted in lieu thereof:
