SUBJECT: REQUEST TO USE DIFFERENT COMMUNICATION TOOL TO
REMIND LICENSEES OF RESPONSIBILITIES REGARDING
DISPOSAL OF SOURCES

The purpose of this memorandum is to request the Commission redefine the communication tool directed in SRM-M090417, "Briefing on Low Level Waste (LLW) Program" to remind licensees of their regulatory responsibilities regarding the disposal of sources. The Commission specifically directed staff to work with the Organization of Agreement States (OAS) and the Conference of Radiation Control Program Directors (CRCPD) to issue an information notice as the communication tool for this task.

During discussions between Office of Federal and State Materials and Environmental Management Programs (FSME) staff, the OAS and CRCPD, the Agreement States and U.S. Nuclear Regulatory Commission (NRC) staff concluded that a comprehensive communication tool that provides practical guidance that could be updated routinely was required instead of an information notice. Discussions with licensees also indicated the need for information that would assist them in the disposal of LLW and radioactive sources. Consequently, Agreement State and NRC staff agreed that the development of a web page on the FSME external website would best serve the needs of the regulators and regulated communities. The FSME external website has effectively served as a clearinghouse for regulatory information used by the Agreement States, the NRC, and their respective licensees since 1996 (<http://nrc-stp.ornl.gov>). The addition of a web page on LLW and source disposal would provide a consolidated source of information on the regulatory requirements and provide practical guidance that could be used by all stakeholders. The availability of the web page will be communicated to Agreement States and materials licensees through a variety of existing lines of communications including the FSME newsletter and FSME letters.
