This letter refers to our public information meeting conducted at the Augusta Technical College, 216 Highway 24 S, Waynesboro, GA 30830, on December 16, 2009. The purpose of this meeting was to describe the NRC's Construction Inspection Program for the time frame covered by the approved Early Site Permit and Limited Work Authorization for Vogtle Units 3 & 4. The meeting was beneficial and provided the public with information regarding the mission of the NRC's Center for Construction Inspection (CCI) located in Atlanta, GA. Additionally, the meeting provided an overview of the CCI organizational structure and staffing, a description of the construction inspection program, and an overview of near-term construction related inspection activities for Vogtle Units 3 & 4.
