Mr. Ryder,

As a follow-up to our phone conversation, Westinghouse requests a 30 day extension to reply to Notice of Violation 70-115/2009-201-01. The reasons for this request are documented below:

- Your response (dated December 1, 2009) to our initial reply did not arrive at our facility until December 13, 2009. This loss of several days significantly impacts our ability to produce a quality reply to your letter.
- Because of the Holidays, several key members of our staff are out on vacation, again impacting our ability to produce a quality reply.
- Westinghouse feels that it is imperative, prior to our reply, that we have a discussion with NRC staff regarding the details of your response to our initial reply letter. In your response, it is documented that "Westinghouse's corrective actions to restore compliance for each of the three systems are considered adequate." However, in the same paragraph, the methodology utilized to accomplish that corrective action was deemed unacceptable. We would like to discuss and clarify NRC

expectations in this matter, prior to replying to the NOV. This will help ensure that we provide a quality response that meets NRC expectations.
