NOTICE OF HEARING FOR CONSOLIDATED EDISON COMPANY'S INDIAN POINT 2 PLANT

On October 5, 1970, the President of the Consolidated Edison Company of New York, Inc., in a letter addressed to the Chairman requested that a public hearing be scheduled on the Company's application for an operating license for its Indian Point Nuclear Generating Unit No. 2.

In accordance with that request, we have prepared for the Commission's consideration a notice of hearing scheduling a public hearing on the application in the New York State Armory, 9551 Washington Street, Peekskill, New York, on December 17, 1970. The prehearing conference is scheduled for December 1, 1970, at the Hendrik Hudson High School in Montrose, New York. This schedule has been approved by the Office of the Atomic Safety and Licensing Board Panel.

The notice of hearing prepared for the Commission's consideration sets forth the standard issues for an operating license proceeding and provides an opportunity for members of the public to petition to intervene in the proceeding and to make limited appearances. The notice also permits the atomic safety and licensing board to consider and act upon a request by the applicant for a license authorizing fuel loading and low power testing at not more than one percent of full power (27.5 Mwt).
