

The purpose of this modification is to extend the period of performance from December 31, 2009 to January 31, 2010 at no additional ceiling increase to the Government. Accordingly the contract is modified as follows:

Refer to Section A.2 entitled, "DURATION OF CONTRACT PERIOD (MAR 1987)" is hereby deleted in its entirety and replaced with the following:

"The contract shall commence on July 24, 2009 and will expire on January 31, 2010."

All other terms and conditions remain unchanged including the contract ceiling of \$164,852.40.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
