



## Important Information About Changes to Myrtle Beach Municipal Tax Rate

This chart shows a tax rate of nine percent (9%) for the municipality of Myrtle Beach, SC (it is designated on the chart as **HORRY (MB)**) with an effective date of August 1, 2009.
