This shipment consists of 15 x 48Y Cylinders loaded on 16 x 20' flatracks. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 123,414 kgs. The net weight of U-235 is 885 kgs.

3) Transportation and Route Schedule

The surface transportation from Metropolis, IL to Paducah, KY will be the responsibility of TAM International Inc. The US inland transportation from Paducah, KY to Portsmouth, VA will be the responsibility of R & R Trucking. The ocean transportation from Portsmouth, VA to Liverpool, UK will be the responsibility of Atlantic Container Line. Export from the United States will occur at Portsmouth, VA on or about August 7, 2009.
