RE: Approval of Addendum to Update #5 to Drilling Notification 334DN, Lost Creek ISR, LLC, Fall 2009 Drilling activities, TFN 5 5/132

Dear Mr. Cash:

With the recommendation of Melissa Bautz, Natural Resources Analyst District II, Addendum to Update #5 to Drilling Notification No. 334DN is hereby approved. Update #5 was originally approved by LQD on March 24, 2009 for the drilling of 160 exploration/delineation holes and the installation of 40 monitoring wells. Since the approval of Update #5, LC learned that the Nuclear Regulatory Commission (NRC) does not authorize the installation of monitoring wells at the site pre-license.

Prior to learning of NRC's determination, in the spring of 2009 LC installed 15 of the 40 wells (under Update #5). In light of the NRC's determination, LC will not install any more monitoring wells at the site. Because 15 of the 40 LQD-approved wells have already been installed, 25 planned wells remained under Update #5 to 334DN.

In place of installing the remaining 25 wells under Update #5, LC plans to drill an additional 118 exploration/delineation holes. This would raise the total number of exploration/delineation holes approved under Update #5 to 278 (160 plus 118). The summary table below depicts the total bond allocated to each year/Update of the 334DN project.

The currently approved bond for 334DN is for \$2,090,300, which is greater than the required bond in the table above. Therefore, there is adequate bond available to cover the proposed 118 additional exploration/delineation holes in this addendum.

Please be advised Lost Creek ISR is solely responsible for obtaining surface and mineral consent prior to commencing drilling activities.
