The purpose of this modification is to (1) Provide incremental Funds in the amount of \$20,000.00 and (2) increase the contract ceiling amount by \$20,000.00 from \$939,500.00 to \$959,500.00. Accordingly, the contract is modified as follows:

(1) Refer to Section B.2 entitled, "CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988)", paragraphs (a) and (b), first sentence are deleted in their entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$959,500.00.

(b) The amount presently obligated with respect to this contract is \$959,500.00."
