On October 20, 2009, Todd Jackson of this office and Nima Askeboussi of NRC's Office of Federal and State Materials and Environmental Management Programs conducted a safety inspection at the above address.. This inspection was conducted as part of our effort to contact companies handling lamps containing exempt quantities of byproduct material to discuss NRC licensing requirements for distribution of certain lamps. In addition, the inspectors reviewed your corrective actions taken in response to a Notice of Violation dated May 20, 2005, sent by the NRC to Mr. Michael Carattini of Robe America. In-office review of information gathered during and following the inspection continued through December 17, 2009. The findings of the inspection were discussed with you at the conclusion of the inspection at your location.

Within the scope of this inspection, no violations were identified.
