Dear Ms. McIntosh:

On October 29, 2009, General Motors LLC submitted to the Nuclear Regulatory Commission (NRC) its response to a Demand for Information dated May 29, 2009 and received on June 1, 2009.

In our response, General Motors LLC indicated that General Motors LLC recently acquired five U.S. facilities from Delphi Corporation. General Motors LLC further indicated that no information was being provided for the former Delphi plants, but that General Motors LLC would supplement our responses once the information is obtained. General Motors LLC is now reporting an additional 10 Tritium Containing Exit Signs (TCES) that are located within the newly acquired Delphi operations (Appendix I). Six devices are located within GM Components Holding LLC facilities and four devices are located at the Steering Solution Services Corporation - Saginaw facility (see Table 1 below).

General Motors LLC is also updating the number of TCES devices that was initially reported in our October 29, 2009, correspondence. Further site reviews at two General Motors LLC facilities have discovered an additional 21 TCES devices above what was initially report to the NRC on October 29, 2009, bringing the new General Motors LLC TCES device total to 441 devices (see Table 1).


