Subject: Transnuclear, Inc. Updated Near Term and Long Term Licensing Plan

Reference: Letter from Donis Shaw (TN) to NRC Document Control Desk, "Transnuclear, Inc. Updated Near Term and Long Term Licensing Plan," E-26975, August 27, 2008

Consistent with the guidance in RIS 2005-27, Transnuclear Inc. (TN) submitted the referenced letter to NRC which communicated our near term and long term licensing plans in 2008. This letter submits to NRC the updated near term licensing plans (Table 1) and long term licensing plans (Table 2). Currently TN has the following items under NRC review:

- An application for Amendment 11 to NUHOMS® CoC 1004 was submitted to NRC for review and approval in April 2007 and supplemented in August and December 2007, June 2008 and August 2009.
- An application for Amendment 1 to NUHOMS® HD CoC 1030 was submitted to NRC for review and approval in November 2007 and supplemented in December 2008 and February, April, May, June, and September 2009. TN's understanding from discussions with the NRC staff is that the amendment package will be noticed in the Federal Register on or about February 17, 2010 and without significant adverse public comments will be effective on or about May 1, 2010.
- TN submitted a transportation package application for the TN-40 Cask to NRC for review and approval in August 2006 and supplemented in June 2007, August 2008, and December 2009.
- TN submitted a request for Revision 3 to transportation package NUHOMS® MP-197, CoC 9302 in April 2009 and supplemented in June 2009. TN received a request for additional information on December 2, 2009. TN plans to submit responses by the requested date of March 2, 2010.
- TN submitted a request for Revision 15 to transportation package ANF-250, CoC 9217 in December 2009.


Additionally, an application for Amendment 12 to NUHOMS® CoC 1004, associated with the U.S. DOE Transportation Aging and Disposal (TAD) Project, and a request for Revision 4 to transportation package NUHOMS® MP-197, CoC 9302, also associated with TAD, were submitted for review and approval in September 2009. NRC returned both submittals in December 2009, due to lack of funding for TAD reviews.

The future licensing plans contained in Tables 1 and 2 are proprietary in nature and in accordance with 10 CFR 2.390(b), an affidavit is provided specifically requesting that you withhold this information from public disclosure.

This section of the document has been appropriately designated as proprietary.


I have personal knowledge of the criteria and procedures utilized by Transnuclear, Inc. in designating information as a trade secret, privileged or as confidential commercial or financial information.

Pursuant to the provisions of paragraph (b) (4) of Section 2.390 of the Commission’s regulations, the following is furnished for consideration by the Commission in determining whether the information sought to be withheld from public disclosure, included in the above referenced document, should be withheld.


- 1) The information sought to be withheld from public disclosure is a list of TN’s identified future licensing action plans, which involve considerable research and development of intellectual property by Transnuclear, Inc.
- 2) The information is of a type customarily held in confidence by Transnuclear, Inc. and not customarily disclosed to the public. Transnuclear, Inc. has a rational basis for determining the types of information customarily held in confidence by it.
- 3) The information is being transmitted to the Commission in confidence under the provisions of 10 CFR 2.390 with the understanding that it is to be received in confidence by the Commission.
- 4) The information, to the best of my knowledge and belief, is not available in public sources, and any disclosure to third parties has been made pursuant to regulatory provisions or proprietary agreements which provide for maintenance of the information in confidence.
- 5) Public disclosure of the information is likely to cause substantial harm to the competitive position of Transnuclear, Inc. because:

- a) A similar product is manufactured and sold by competitors of Transnuclear, Inc.
- b) The availability of such information to competitors would enable them to modify their product to better compete with Transnuclear, Inc., take marketing or other actions to improve their product's position or impair the position of Transnuclear, Inc.'s product, and avoid developing similar data and analyses in support of their processes, methods or apparatus.
- c) In pricing Transnuclear, Inc.'s products and services, significant research, development, engineering, analytical, licensing, quality assurance and other costs and expenses must be included. The ability of Transnuclear, Inc.'s competitors to utilize such information without similar expenditure of resources may enable them to sell at prices reflecting significantly lower costs.
