Dear Sir or Madam:

In September 2009 Owens Corning's specific license number 34-18712-02 was amended to 1) extend the expiration date to January 31, 2010 and, 2) accommodate a split in the license so that those devices used at our Kearny, New Jersey Roofing Plant could be transferred and covered by license with the state of New Jersey which was recently granted Agreement State status with the NRC. The only remaining device on the amended license referenced above is one source for our Brookville, Indiana Roofing Plant.

A review of our records at the Brookville Plant shows that this remaining source, a 10 mCi source in an Amersham Model SIF (X.117 capsule) used in an NDC Systems Model 301 source holder for thickness and mass measurement, was decommissioned and returned to Eurotherm Gauging Systems, Inc. on 08-February, 2002. Attached is documentation of the decommissioning and return confirmation of the source to Michael Woodward of Eurotherm Gauging Systems, Inc. Consequently, we are requesting that specific license 34-8712-02 be terminated. While the Brookville Roofing Plant has five sealed sources gauging devices, all of the remaining sources are covered by general license through their manufacturers and have been registered with the NRC under reference number GLTS-A-705021.
