Gentlemen:

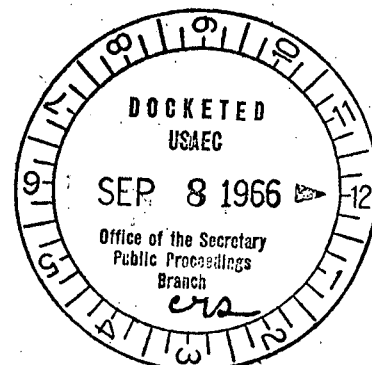
