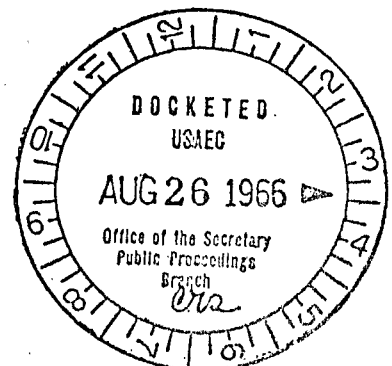
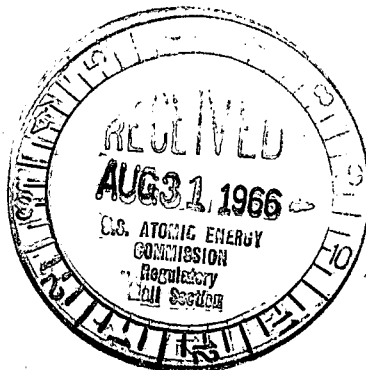
Due to the heavy schedule of Congressional business which will require my presence in Washington at the earliest possible hour, I would appreciate being scheduled as the first witness.
