The intervenor Environmental Defense Fund, Inc., on December 1, 1970, moved for entry of an order "adjourning the proceeding or withdrawing the notice of hearing until the Applicant has complied with Appendix D of Part 50 of 10 CFR, until the AEC has complied with the requirements of the National Environmental Policy Act of 1969 and until the notice of hearing has been re-issued to indicate the full scope of environmental issues to be considered at this hearing as required by the National Environmental Policy Act of 1969 - and until such further reasonable time as shall be required for intervenor and other interested members of the public to prepare for hearings on the issues which are raised by the proper application of the National Environmental Policy Act".

Intervenor, New York State Atomic Energy Council respectfully requests that such motion be denied, on the grounds that under the Commission's Rules, including Appendix D of 10 CFR Part 50, applicable to this proceeding, all issues appropriate for consideration by the Board in this proceeding are as set forth in the Commission's notice of hearing dated November 13, 1970, and as to such issues Environmental


