TAKE NOTICE that the Atomic Safety and Licensing Board in this proceeding orders that a conference type of hearing shall convene at 9:30 A.M. on Wednesday, March 24, 1971, in the Auditorium of Hendrik Hudson High School, Albany Post Road, Montrose, New York.

The primary purpose of this conference type of hearing will be to consider and determine further procedures to expedite the presentation of evidence relative to the issues prescribed for hearing, to express requests for evidence relevant to this cause, to prescribe a schedule for the submission of the evidence intended to be adduced in the proceeding, and to designate, if possible, the date when a continuous session of hearings can convene to consider all of the evidence proposed to be offered by the parties.


The Applicant has requested that, at the conference hearing, its responses to requests for evidence presented by the Board


