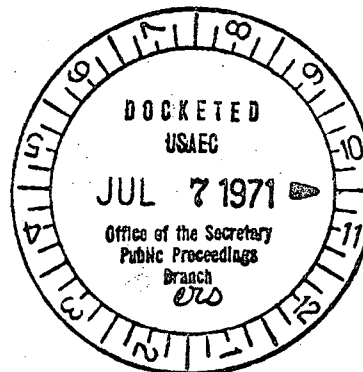

There are enclosed copies of answers to questions raised by members of the Atomic Safety and Licensing Board at the hearings on March 24, 1971 and May 13, 1971. With the exception of the question asked by Mr. Briggs at page 687 of the transcript regarding the emergency core cooling system, this completes the Applicant's responses to questions raised by the Board. Applicant intends to offer these answers in evidence at the hearing on July 13. The testimony entitled "Answers of Applicant to Questions Raised by Atomic Safety and Licensing Board on March 24, 1971 - Part II" will be sponsored collectively by Messrs. Prestele, Grob, Moore, McAdoo and Wiesemann. The testimony entitled "Answers of Applicant to Questions Raised by Atomic Safety and Licensing Board on May 13, 1971" will be sponsored collectively by Messrs. Grob, McAdoo, Wiesemann and Fletcher.

In addition there are enclosed copies of a document entitled "Additional Testimony of Applicant - Part I". This document contains testimony in response to the evidence proposed to be introduced

by the Citizens Committee for the Protection of the Environment by its letter to the Board dated June 4, 1971. Applicant intends to offer this testimony at an appropriate time in the coming session of hearings under the sponsorship of the individual witnesses identified therein.

Applicant intends to provide to the Board by July 9, 1971 copies of additional testimony in response to the Citizens Committee's contentions in its June 21 proposed findings concerning the need for power from Unit No. 2.
