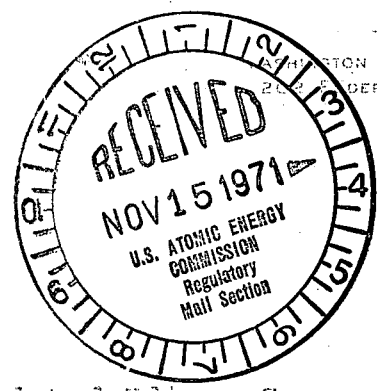

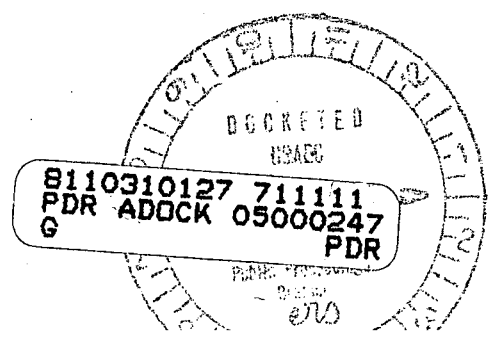

Dear Sir:

This letter is in reference to the motion filed on August 17, 1971 by Consolidated Edison Company of New York, Inc. (Applicant) with the Commission for an order establishing further procedural requirements to implement the National Environmental Policy Act of 1969.

On November 2, 1971 Applicant executed a stipulation with the Citizens Committee for the Protection of the Environment, the Environmental Defense Fund, Inc. and the Hudson River Fishermen's Association, intervenors in this proceeding, relating to further conduct of the proceeding. The stipulation was filed with the Secretary of the Commission on November 4, 1971. By letter dated November 3, 1971 the Hudson River Fishermen's Association requested Applicant to withdraw the above referenced motion.

Consistent with the stipulation and the understanding reached with the intervenors, Applicant hereby withdraws its motion of August 17, 1971. In so doing, Applicant reserves
