

We were pleased to learn from your notice of December 3, 1971 that hearings will be resumed on December 14th with regard to the license application submitted by Consolidated Edison for operating Indian Point Nuclear Generating Unit #2.

The City's power supply is greatly dependent upon this plant. Unless it is on line this summer, we face the possibility of a power crisis this summer. We are equally concerned that this plant meet environmental impact requirements.

Our Committee, therefore, strongly urges that the Atomic Safety and Licensing Board conduct continuous hearings on this application until the proceedings are completed.
