

Dear Mr. Chitwood:

We today received a copy of a letter dated November 8, 1972 from counsel for the Citizens Committee for the Protection of the Environment. We have the following comments on Mr. Roisman's letter:

> On November 7, 1972 we forwarded to Mr. Roisman a copy of Con Edison's application to receive, possess, store, but not use, special nuclear material at Indian Point 2. This was sent in conformance with Chairman Jensch's request in Docket No. 50-247 (Tr. 5446 to 5450) and consistent with our practice for the past several months. Con Edison was under no obligation whatsoever to furnish Mr. Roisman a copy of the application prior to that time. Indeed, it was only because we desired to comply with the spirit of Chairman Jensch's request that we furnished the document to him at all.

- 2. Mr. Roisman's accusation that Con Edison intentionally violated Chairman Jensch's order is offensive and utterly false.
- 3. In stating that the Citizens Committee for the Protection of the Environment "intends to vigorously oppose permitting Con Ed to possess any nuclear materials," Mr. Roisman apparently has forgotten that his client did not oppose Con Edison's motion for a fuel loading and subcritical testing license for the Indian Point 2 facility, which license was granted over a year ago.
- 4. Mr. Roisman has not stated any basis for postponement of a licensing action by the AEC under 10 CFR Part 70.
