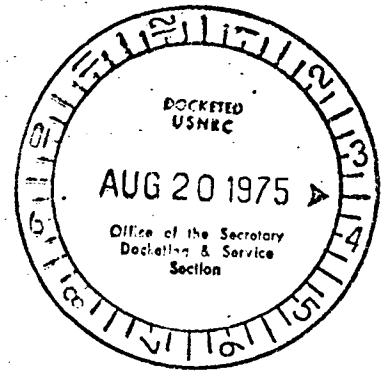

REQUEST FOR A HEARING

Pursuant to § 2.105(d)(1) of the Rules of Practice of the Nuclear Regulatory Commission, 10 C.F.R. § 2.105(d)(1) (1975), and the Notice of Proposed Issuance of Amendment to Facility Operating License and Notice of Opportunity for Hearing issued on July 15, 1975, 40 Fed. Reg. 30882 (1975), Consolidated Edison Company of New York, Inc. ("Con Edison"), as holder of Facility Operating License No. DPR-26, hereby requests a hearing with respect to its application for facility license amendment filed on December 2, 1974, and urges that the hearing be held in the vicinity of Indian Point.

At the hearing, Con Edison will urge that the relief requested in its application for facility license amendment be granted.

The need for a hearing will, from Con Edison's point of view, be obviated if the Regulatory Staff determines that the relief sought in the December 2, 1974 application should be granted without change. If the Regulatory Staff so concludes, then the instant request for a hearing is to be considered withdrawn. If, however, any other requests for a hearing are filed, then Con Edison will appear at and participate in the hearing (if one is granted) in support of the amendment for which Con Edison has applied.

Finally, if the Regulatory Staff concludes that a form of closed-cycle cooling other than a natural draft wet cooling tower is preferable, Con Edison requests that the hearing also cover the question whether the amendment approved should, because of the time needed for the design and installation of any such system other than a natural draft cooling tower, include an extension of the date beyond which operation with once-through cooling will not be permitted. Such extension beyond the period now stated in the license would be separate from the extension requested for other reasons in the application to amend

the operating license filed by Con Edison on June 6,  
1975.




