Reference Task Order RES-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) increase the task order ceiling, and (2) add incremental funding, as follows:

1. Increase the ceiling of Task Order RES-001 by \$29,732.92, from \$136,844.93 to \$166,577.85.

An estimated price schedule showing Option Year Two, as well as the total task order ceiling, is attached.

The period of performance of Task Order RES-001 is from November 1, 2007 through September 20, 2010.

2. Add incremental funding in the amount of \$22,000.00, thereby increasing the obligated amount from \$98,722.08 to \$120,722.08.
