PETITION FOR LEAVE TO INTERVENE
BY THE NEW YORK STATE ATOMIC
ENERGY COUNCIL

1. The U.S. Nuclear Regulatory Commission (the Commission) caused to be published in the Federal Register on Wednesday, July 23, 1975, (Vol. 40, No. 142, p. 30882) a document dated July 15, 1975 and entitled, "Proposed Issuance of Amendment to Facility Operating License Opportunity for Hearing for Indian Point Nuclear Generating Unit 2".
2. The noticed proceeding, if convened, would consider the application of The Consolidated Edison Company of New York, Inc., for an amendment to Facility Operating License No. DPR-26 issued to Consolidated Edison for operation of Indian Point Unit No. 2, which would authorize the Consolidated Edison Company to construct as a preferred closed-cycle cooling system, a Natural Draft, wet cooling tower for Indian Point Unit No. 2.
3. The interest of the State of New York in the health, safety and environment of its people requires in any hearing which may be held that all matters pertaining to the safety and environmental impact of the proposed nuclear power plant modification be thoroughly considered.

4. Under section 104 of the Commerce Law of the State of New York, entitled "General functions, powers and duties of council", the New York State Atomic Energy Council is given responsibility for coordinating regulatory programs of the State agencies and instrumentalities which affect atomic energy activities in New York, of developing a coordinated position among State agencies with respect to Federal regulatory matters and of coordinating the participation of the agencies and instrumentalities of the State in the regulatory process of the Federal Government where such Federal process affects atomic energy activities in the State.

5. Pursuant to Section 2.715(c) of the Commission's Rules of Practice and Section 274 of the Atomic Energy Act of 1954, as amended, and in accordance with the provisions of the Commission's Notice of Proposed Issuance of Amendment to Facility Operating License Opportunity for Hearing for Indian Point Nuclear Generating Unit 2, dated July 15, 1975, the State of New York, acting by and through its Atomic Energy Council, hereby petitions for leave to intervene in any hearing which may be held on these matters. The Atomic Energy Council through its participation in these proceedings under Section 274 of the Act asserts the full statutory right of participation by an interested state and for certain procedural purposes will consider itself a "party" as that word is used throughout Part 2 of the Rules of Practice.




