NOTICE OF HEARING DATED JANUARY 30, 1976

• Section 2.705 of the rules of practice provides that a party may file an answer which must concisely state:

1. The nature of his defense or other position;
2. The items of the specification of issues he controverts and those he does not controvert; and
3. Whether he proposes to appear and present evidence.

The New York State Atomic Energy Council participates in this proceeding under Section 2.715(c) which section affords New York State the right to be represented on the issues to be considered by this Board and to have a reasonable opportunity to generally participate in the hearing, to interrogate witnesses, introduce evidence and otherwise advise the Commission without requiring that the State take a position with respect to the issues.

New York State intends to fully participate in this hearing in order to insure that a full record is developed on the matters before this Board, and will not pre-judge the issues prior to the close of this record. We anticipate being


