SUMMARY
We have reviewed your new license application dated October 8, 2009, and find that we need additional information as follows:

1. In NRC Form 313, Item 2 of your application, please verify the name of your organization.
2. In the attached Radiation Safety Officer/Executive Management Letter of Understanding dated October 12, 2009, please provide a copy of this letter with Executive Management signature.
3. From NUREG 1556, Vol.9, Rev. 2 Item 9 Radiation Monitoring Instruments, please provide a description of the instruments to be used to perform required surveys and also include statements on the replacement of these instruments.
4. Please verify if you are requesting to have PET radionuclides authorized. If yes, please provide the information referenced in NUREG-1556, Vol. 9, Rev. 2 Item 9 Facilities and Equipment, i.e. shielding calculations, "quiet room", etc.
5. In Item 10 Occupational Dose, you provided the incorrect NUREG reference with your submittal. Please respond by requesting "Either we will perform a prospective evaluation demonstrating that unmonitored individuals are not likely to receive, in 1 year, a radiation dose in excess of 10% of the allowable limits in 10 CFR Part 20 or we will provide dosimetry that meets the requirements listed under 'Criteria' in NUREG-1556, Vol. 9, Rev. 2, 'Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Medical Use Licenses.'"

We will be unable to continue processing your request until we receive this information. In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically in the NRC Public Document Room or from the Publicly Available Record (PARS) component of NRC's document system (ADAMS) accessible from the NRC Website at <http://www.nrc.gov/reading-rem/adams.html>.


