The purpose of this modification is to (1) reduce the level of effort, (2) reduce the contract ceiling by \$83,883.00 from \$245,568.00 to \$161,685.00, (3) deobligate funds in the amount of \$83,883.00 thereby reducing the total obligations from \$245,568.00 to \$161,685.00, (4) extend the period of performance from May 18, 2010 to September 18, 2010 and (5) accept ISL's 2009 Provisional Billing/Forward Pricing Rates for this Task Order No. 04. Accordingly, the subject Task Order is modified as follows:

NOTE: The Task Order No. 04 "Statement of Work" remains unchanged.

Task Order No. 04 shall be in effect from November 19, 2007 through September 18, 2010, with a cost ceiling of \$161,685.00. The amount of \$153,082.00 represents the estimated reimbursable costs, and the amount of \$8,602.00 represents the fixed fee.

The amount obligated by the Government with respect to this task order is \$161,685.00, of which \$153,082.00 represents the estimated reimbursable costs, and the amount of \$8,602.00 represents the fixed fee.
