The purpose of this modification is to provide incremental funding in the amount of \$200,000.00 thereby increasing the total obligations from \$450,000.00 to \$650,000.00 and to extend the period of performance from March 31, 2010 to September 30, 2010. Accordingly the contract is modified as follows:  
"The amount obligated by the Government with respect to this task order is \$650,000.00, of which \$603,192.00 represents the estimated reimbursable costs, and the amount of \$46,808.00 represents the fixed fee.  
"The Period of Performance is from January 28, 2009 through September 30, 2010."  
All other terms and conditions remain the same including the contract ceiling of \$708,405.00.
