This letter transmits to you our report of the routine inspection conducted by Mr. Lawrence W. Rossbach and Mr. Peter W. Kelley of this office on September 1, 1987 to October 5, 1987 at Indian Point Nuclear Generating Station, Unit 2, Buchanan, New York. The report reviews activities authorized by NRC License No. DPR-26, and includes discussions of our findings held by Mr. Rossbach and Mr. Kelley with you and your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that two of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. These violations have been categorized by severity level in accordance with the General Statement of Policy and Procedure for NRC Enforcement Actions, 10 CFR Part 2, Appendix C (Enforcement Policy 1986). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

This letter also acknowledges receipt of your revised response dated September 15, 1987, to the violation cited in Inspection Report 50-247/87-01. Your corrective actions will be reviewed during a future inspection.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
