License Renewal Application for Diablo Canyon Power Plant

On January 8, 2010, the staff completed the acceptance review of the license renewal application for the Diablo Canyon Power Plant, Units 1 and 2. The staff determined that the application contains sufficient information for docketing. On November 24, 2009, the staff received the license renewal application from Pacific Gas and Electric Company, requesting the extension of the operating licenses for an additional 20 years beyond the current 40-year terms, pursuant to 10 CFR Parts, 51 and 54. Diablo Canyon Power Plant, Units 1 and 2, are pressurized water reactors designed by Westinghouse with current operating licenses that expire at midnight on November 2, 2024, and August 26, 2025, respectively. The staff plans to hold public information sessions near the plant site in the near future to describe the license renewal process.

Meeting with the Nuclear Energy Institute Regarding Pressurized-Water Reactor Licensees

On January 13, 2010, the staff held a public phone conference with representatives of the Nuclear Energy Institute and interested licensees to discuss staff plans to issue requests for information in accordance with 10 CFR 50.54(f) to pressurized-water reactor licensees who referenced certain technical reports as part of addressing Generic Letter 2004-02, which pertains to pressurized-water reactor emergency core cooling system sump performance. The reports in question are intended to justify licensee use of a reduced zone of influence. Certain staff concerns regarding these reports have not been resolved.

Meeting with Boiling Water Reactor Owners Group (BWROG)

On January 14, 2010, the staff met with representatives of BWROG to discuss the BWROG planned approach to addressing in vessel impacts of debris that might bypass the emergency core cooling system strainers in a boiling water reactor.

Withdrawal of Regulatory Guide (RG) 7.5, “Administrative Guide for Obtaining Exemptions from Certain NRC Requirements over Radioactive Material Shipments”

On January 12, 2010, staff published a *Federal Register* Notice announcing the withdrawal of RG 7.5 titled, “Administrative Guide for Obtaining Exemptions from Certain NRC Requirements over Radioactive Material Shipments.” The RG provided guidance on obtaining a modification, waiver, or exemption from the NRC-imposed Department of Transportation regulations via 10 CFR 71.5(b). NRC is withdrawing RG 7.5 because the guidance is no longer needed.

Publication of Draft Regulatory Guide 8037 (DG-8037) “Information Relevant to Ensuring that Occupational Radiation Exposures at Medical Institutions will be as Low as is Reasonably Achievable”

On January 14, 2010, staff issued DG-8037 to provide an opportunity for public comments. The draft guide is proposed Revision 2 to Regulatory Guide 8.18, which is directed specifically toward medical licensees and recommends methods that the NRC staff considers acceptable to maintain occupational exposures as low as is reasonably achievable in medical institutions. NRC Acquisition Organizational Assessment

On January 6, 2010, as a result of a non-competitive acquisition under the General Services Administration Federal Supply Schedule, a labor hour task order (NRC-DR-10-10-393) was awarded to Ernst & Young in McLean, Virginia for an acquisition organizational assessment and recommendations. The period of performance is January 6, 2010, through January 5, 2011. The total price for this order is \$963,676.36.

Association of State and Territorial Solid Waste Management Officials; Notice of Receipt of Petition for Rulemaking, 10 CFR Part 32 (PRM-32-6, NRC-2009-0547)

On January 12, 2010, the NRC published a notice of receipt (75 FR 1559) requesting comments on a petition for rulemaking dated November 6, 2009, filed by the Association of State and Territorial Solid Waste Management Officials. The petitioner requests that the NRC amend its regulations and/or guidance to improve the labeling and accountability of tritium exit signs. The petition has been assigned Docket No. PRM-32-6. The comment period closes March 29, 2010.
