Dear Sir:

This letter comes to you from a private citizen who is extremely concerned with the state of this country's ecological condition. Having read the February 1972 issue of Science Digest's article on the Indian Point Nuclear Plant in Peekskill, New York, I am even more upset that you as Chairman could let things like this happen.

The heated water that is sent back to the rivers and streams is detrimental to our ecology on many points. It expends the oxygen content which cleanses the rivers and streams and the oxygen also supports the life in the water. This heat supports the growth of algae which uses up whatever little oxygen is left from the first effect. And, too, the heat increases the decomposition of sewage and other organic material produces, as the article states, an "odorous, vile-looking sewer supporting no life but bacterium."

If these facts aren't bad enough to convince you that this type of nuclear plant is bad, consider this. Twice in 1970, the Indian Point Plant had to stop the reactor when a total of 270,000 fish were wiped out by the plant's suction pipe. The death of this many fish at once, plus all the algae and lack of oxygen, disrupts the ecosystem of that river and the surrounding area. Ultimately, this disruption has an effect on our lives, since we, as tertiary consumers of these fish, will lose out. This situation would be bad enough if Indian Point were the only nuclear plant in the United States, but there are plants all over

the country.

Surely, Sir, there is another way to produce energy without all this ecological damage. I fervently agree that nuclear power is better than fossil fuel. But I also believe there are other types far superior to the present energy producing system; types that are less polluting, yet will still produce the amounts of energy our country will need. The "fast breeder" is an improvement and seems to be getting the most support, financially, from President Nixon, but I feel this support should be concentrated on the fussion reactor.

I encourage the development of this type of reactor since the cost is relatively low with the utilization of sea water. It would also be cleaner with tritium as the only bothersome waste, and the reactor would be safer because fussion would stop when the reaction cools even slightly.

You are in the position to stress the points of preserving this portion of our ecology. I urge you to use your influence in saving our rivers, streams and wildlife, not to mention our lives, and to change our present system of destruction.



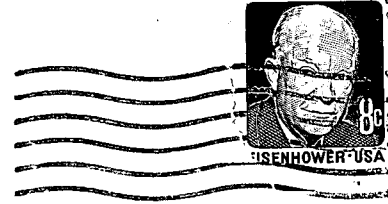
