- 1) Answers to the Nureg 1556 Vol. 4 App. C:
 - a. Name changed to WV Alloys Manufacturing, LLC
 - b. Contacts are the same
 - c. No change to personnel having control over the licensed activities.
 - d. Current USNRC license will transfer to entirely to WV Alloys Manufacturing, LLC. For the intent of this license transfer, the only thing that changed was the name of the company.
 - e. On September 25, 2009 the WVA Manufacturing, LLC was formed as a limited liability corporation under the Delaware Limited Company Act. On October 28, 2009, West Virginia Alloys, Inc. contributed all of its net assets (excl. accounts receivable and finished goods) to WVA Manufacturing, LLC to begin operations. On the same day, Globe Metallurgical, Inc. (West Virginia Alloys, Inc.'s parent) contributed assets related to the alloy plant. On November 5, 2009, admitted Dow Corning as a member with a 49% interest in WVA Manufacturing, LLC. Today, Globe maintains a 51% interest in WVA Manufacturing, LLC with Dow Corning holding the remaining 49%.
 - f. No changes anticipated.
 - g. No changes in use.
 - h. No changes to organization, location, facilities, equipment, procedures or personnel at this time.
 - i. All calibrations, leak tests, surveys are current.

- j. All elements of item 10 have been transferred to the new company.
 - k. There is no contamination present.
 - l. No contamination present therefore item 11 should not apply.
 - m. As the RSO, I agree that WV Alloys Manufacturing, LLC will continue to abide to all USNRC regulations and license requirements.
 - n. As the RSO, I agree that the control of the and activity licensed material will remain the same as in the past.
 - o. As the RSO, I agree that all constraints, conditions, requirements, representations and commitments identified in the existing license will be adhered to.
