EVALUATION OF REVISION OF MARCH 21, 1973 TO APPENDIX B TO FACILITY OPERATING LICENSE DPR-26, INDIAN POINT NO. 2

INTRODUCTION

During the Atomic Safety and Licensing Board (ASLB) hearings on March 7 and 8, 1973 a stipulation between the parties in the proceeding was made such that the references to the requirement of thermal model testing in the proposed environmental technical specifications would be deleted. These proposed environmental technical specifications will become Appendix B to Operating License DPR-26 when it is amended to allow for testing up to 50% of rated power. Accordingly, pages 2-4 and 6-10 of Appendix B submitted to the ASLB on September 21, 1972 require revision as discussed below. (Reference ASLB Hearing TR 9853 and 9954)

DISCUSSION

This revision removes the requirement to determine the effectiveness of the thermal model during the normal startup testing program. The effectiveness of the model will be determined in a timely manner after issuance of the full power license to assure compliance with New York water quality thermal criteria.

This revision will reassure that the testing period will not exceed the 100 day period for testing agreed upon in the stipulation.

CONCLUSION

We have concluded that this change does not present significant hazards considerations not described or implicit in the Safety Analysis Report. There is reasonable assurance that the health and safety of the public will not be endangered by this change; therefore, this change can be made.
