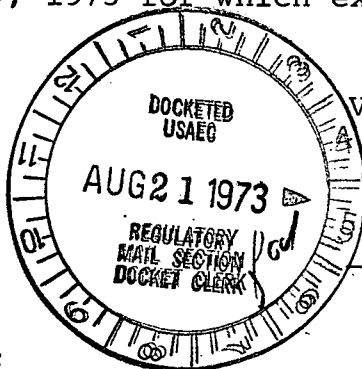


Dear Mr. Giambusso:

In accordance with your letter of November 20, 1972, Consolidated Edison Company of New York, Inc., hereby transmits forty (40) copies of the report entitled "Fuel Densification -- Indian Point Nuclear Generating Unit No. 3", dated July, 1973.

Consolidated Edison notes that although the analyses in the report transmitted herewith did not address the use of part length control rods, we are interested in reviewing the use of such rods with the Staff at an appropriate time in the future.

We understand that this report on fuel densification contains proprietary material of Westinghouse Electric Corporation and, therefore, request that all copies of this report be withheld from public disclosure pursuant to Section 2.790 and 9.5 of the Commission's Rules and Regulations. In support of this request, we are enclosing a document entitled, "Application to Withhold Material from the Public Record". In accordance with the Commission's Rules, we are also enclosing twenty (20) copies of a document entitled "Fuel Densification -- Indian Point Nuclear Generating Unit No. 3" (Westinghouse Non-Proprietary Class III), dated July, 1973 for which exemption from disclosure is not requested.

APPLICATION TO WITHHOLD MATERIAL
FROM THE PUBLIC RECORD

Consolidated Edison Company of New York, Inc.
("Consolidated Edison"), Applicant in the above-captioned proceeding, pursuant to Sections 2.790(b) and 9.5(a)(4)(i) of the Commission's Rules and Regulations, requests that the document transmitted to the Commission by letter dated August 17, 1973, and entitled "Fuel Densification--Indian Point Nuclear Generating Station Unit No. 3", dated July 1973, be withheld in part from public disclosure. In support of this request, Consolidated Edison states as follows:

(1) Consolidated Edison understands that certain parts of the aforesaid document constitute trade secrets, inventions and discoveries and/or proprietary data of Westinghouse Electric Corporation within the meaning of Section 9.5(a)(4)(i) of the Commission's Regulations and


are, therefore, exempted from public disclosure.

(2) Consolidated Edison has transmitted by letter, dated August 17, 1973, copies of a non-proprietary version of the aforesaid document for which exemption from disclosure is not requested.

WHEREFORE, Consolidated Edison requests that the information contained in the aforesaid proprietary document be withheld from public disclosure to the extent that such information is not contained in the submittal made under Paragraph 2 above pursuant to Sections 2.790(b) and 9.5(a)(4)(i) of the Commission's Rules and Regulations.
