As attorneys for Consolidated Edison Company of New York, Inc. and the Power Authority of the State of New York, we hereby transmit three (3) signed originals and forty (40) copies of an application to amend the Technical Specifications designated as Appendix A to Facility Operating License No. DPR-64. This application seeks to clarify the surveillance interval applicable to refueling outage tests performed at the conclusion of the initial fuel cycle, and to make the surveillance interval for testing of containment isolation valves consistent with the provisions of Appendix J to Part 50 of the Commission's regulations.

We are requesting that this application be given an expeditious review in order to avoid the two weeks of
