Dear Mr. Allen:

By letter to the Nuclear Regulatory Commission (NRC) dated December 3, 2009 (Agencywide Documents Access and Management System Accession No. ML093450484), FirstEnergy Nuclear Operating Company submitted two affidavits dated November 20, 2009, executed by Gayle F. Elliott, Manager, Product Licensing, AREVA NP Inc. and Moses Taylor, Jr., Senior Associate, Structural Integrity Associates, Inc. (SIA), requesting that information designated proprietary in the following document be withheld from public disclosure pursuant to paragraph (a)(4) of Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- Structural Integrity Associates, Inc. (SIA) report Number 0800368.404, Revision 0, July 20, 2009.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (a) The use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- (b) The information includes test data or analytical techniques concerning a process, methodology, or component, the application of which results in a competitive advantage for AREV NP.

We have reviewed your submittal in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
