Our letter of June 27, 1977 informed you of a change in primary responsibility for conduct of the nuclear environmental monitoring program and long term or life-of-the-plant type environmental monitoring programs. In addition, effective Friday, July 1, 1977, a Manager, Operations Services was appointed who reports to the Assistant Vice President, Power Generation Operations and to whom the Chief Chemical Engineer reports. Therefore, in accordance with this organizational change the Senior Engineer, Environmental, Nuclear and Gas Testing, now reports via the Division Chemist, Chief Chemical Engineer and Manager, Operations Services to the Assistant Vice President, Power Generation Operations.

For your information, attached is a revised organization chart depicting this change. Please note that we will be submitting an application for an amendment to the Environmental Technical Specification Requirements for all three units at Indian Point to reflect this change.
