SUMMARY OF MEETING TO DISCUSS TRANSFER OF IP-3 OPERATIONAL RESPONSIBILITY FROM CON ED TO PASNY (JULY 27, 1976)

A meeting was held on July 27, 1976, to discuss assumption of operational responsibility by PASNY. PASNY is now the owner of IP-3 and a joint licensee with ConEd.

Mr. W. Hultgren of PASNY stated that PASNY will employ many of the ConEd IP-3 operations personnel prior to the transfer of operations responsibility to PASNY. ConEd would continue to operate IP-3 until the date of actual transfer of responsibility, however.

During this interim period, the ConEd personnel who had accepted employment with PASNY would continue to report to the ConEd organization. When operating responsibility was transferred, these former ConEd personnel would then report to the PASNY organization.

PASNY agreed to provide their schedule and plans for the transfer of personnel and operational responsibility.
