SUBJECT: NOTICE OF AVAILABILITY OF THE FINAL SUPPLEMENTAL
ENVIRONMENTAL IMPACT STATEMENT FOR NORTH ANNA POWER
STATION, UNIT 3 COMBINED LICENSE

Dear Mr. Grecheck:

The U.S. Nuclear Regulatory Commission (NRC) staff has completed NUREG-1917, final "Supplemental Environmental Impact Statement (SEIS) for the North Anna Power Station, Unit 3 Combined License (COL)." The SEIS focuses on the impacts of constructing and operating a new nuclear power plant at the North Anna Site. In addition, the SEIS tiers off of the results of the environmental review conducted in connection with Early Site Permit-003 (ESP). Enclosed is a copy of the *Federal Register Notice of Availability*. This notice advises the public that the final report is available for public inspection at the NRC Public Document Room or from the publicly available records component of NRC's Agency-wide Documents Access and Management System (ADAMS). ADAMS is accessible from the NRC website at <http://www.nrc.gov/reading-rm/adams.html> which provides access through the NRC Electronic Reading Room link. The accession number in ADAMS for the SEIS is ML100680117.

As discussed in the final SEIS, the NRC recommendation related to the environmental aspects of the proposed action is that the COL should be issued. This recommendation is based on: (1) Dominion's COL environmental report; (2) the NRC review conducted for the ESP application and documented in the ESP environmental impact statement (EIS); (3) consultation with Federal, State, Tribal, and local agencies; (4) the NRC independent review of potential new and significant information available since preparation and publication of the ESP EIS; (5) NRC consideration of comments related to the environmental review that were received during the review process; and (6) the assessments summarized in the SEIS including the potential mitigation measures identified in the environmental report and in the SEIS.
