On January 12, 1973. the Hudson River Fishermen's Association ("HRFA") and Save Our Stripers ("SOS"), petitioners to intervene in the above-captioned proceeding, filed their motion to consolidate AEC Docket No. 50-247 with AEC Docket No. 50-286, with supporting materials.

The regulatory staff has requested an extension of time to respond until January 25, 1973. The applicant had requested an extension of time to January 22, 1973 and has filed its answer. The petitioners on January 23, 1973 have filed a "Supplemental Memorandum" clarifying their motion at the request of certain of the parties in the above-captioned proceeding.




