APPLICANT FOR EXTENSION OF TIME"

On January 2, 1973, Hudson River Fisherman's Association (HRFA) and Save Our Stripers (SOS), petitioners to intervene in the above-captioned proceeding, filed a "Motion to Consolidate" with supporting materials.

Finding that the issues raised in petitioners' motion are novel and complex, applicant responded on January 8, 1973, with a request that it be granted an extension of time until January 22, 1973, to respond to the HRFA-SOS motion.




